## Rental Terms and Conditions

### 1. RENTAL PERIOD

The rental period covers all time consumed in the transportation, delivery, and return of the equipment. Each rental is subject to a minimum daily charge of eight (8) hours, with overtime rates applied beyond 8 hours of usage. Equipment is GPS-tracked for accountability. Customer is responsible for any delays or late returns, which may result in additional charges.

### 2. RENTAL CHARGES

All rental rates are based on operated and maintained equipment. Rates are subject to change without prior notice. A four (4) hour minimum applies to all rentals. Overtime charges begin after eight (8) hours; double-time after twelve (12) hours. Weekend and night work are billed at applicable overtime rates. Billing increments are in two-hour blocks after the minimum period.

### 3. PAYMENT

All invoices must be paid in full immediately upon project completion. California Paving Company is not bound to any subcontractor, general contractor, or owner agreements. "Pay-if-paid" and "pay-when-paid" clauses do not apply and are expressly disclaimed. Past due accounts are subject to a 1.5% monthly finance charge. Stop Notices or Mechanic's Liens may result in a \$1,250 fee per project, plus all legal costs.

### 4. PRELIMINARY NOTICES / RELEASES

Preliminary project and owner information must be submitted before dispatch of equipment. Lien Releases must be formally requested through the Company's administrative department.

### 5. FREIGHT

Equipment moves beyond a fifty (50) mile radius from the Company's yard will incur a freight charge at \$175 per hour, portal-to-portal, or an \$800 minimum per move. Additionally, a fuel surcharge of \$150 per piece of equipment is applied daily.

### 6. OPERATORS

Unless otherwise agreed in writing, all equipment is operated by trained and certified California Paving Company personnel. If Customer provides its own operators, Customer assumes full responsibility for compliance with applicable labor laws, workers' compensation, insurance, and supervision. Customer-directed work is fully the responsibility of the Customer.

### 7. PAVING

California Paving Company does not guarantee final asphalt thickness, grading, or drainage outcomes. The Customer is responsible for all final inspection and approval of finished paving work.

### 8. INDEMNITY

Customer agrees to fully indemnify, defend, and hold harmless California Paving Company from and against all claims, damages, injuries (including death), property loss, or costs (including legal fees) arising out of the rental, use, supervision, or operation of the equipment.

### 9. INSURANCE

Customer must provide insurance covering equipment against all risks for no less than its full replacement value, as well as liability insurance with limits of at least \$1,000,000. California Paving Company must be named as both an additional insured and loss payee.

### 10. ENTIRE AGREEMENT

This document represents the entire and exclusive agreement between California Paving Company and Customer. No oral modifications or prior agreements shall modify these terms without written consent signed by both parties.
